Part II: Narrative Explanation

II. A - Brief Description Of What The Measure Does That Has Fiscal Impact on the Courts

Section 2 adds section to Chapter 28A.635 that requires signage, including in a gymnasium and athletic fields, to notify public of the offenses and penalties.

Section 3 adds contractors and volunteers acting as an official, to language making it unlawful to interfere by force of violence. Students who interfere may be excluded from participation in the activity for up to 12 months. Increases penalties for existing gross misdemeanor from not more than \$500 to not more than \$1000, and from not more than six months in jail to not more than 364 days in jail. Upon conviction the person must be excluded from entering the school for no less than 12 months and no more than 18 months.

Section 4 amends RCW 28A.635.100 (Intimidating any administrator, teacher, classified employee, or student by threat of force or violence -- Penalty) to add similar language reference contractor or volunteer.
