II. A - Brief Description Of What The Measure Does That Has Fiscal Impact on the Courts

This bill prohibits a firearms dealer from delivering more than one firearm or more than 100 rounds of .50 caliber ammunition or more than 1000 rounds of any other caliber of ammunition to a purchaser or transferee in any 30-day period. It creates a new Class 1 Civil Infraction with a penalty of \$500 and creates a new Gross Misdemeanor.
