The AOC pays 50 percent of the salary and 100 percent of the benefits for superior court judge positions. The county pays the other 50 percent of the salary cost. This request will pay the state share of the judge position beginning July 1, 2025 at a salary set by the Washington's Citizen's Commission on Salaries for Elected Officials.

ADMINISTRATIVE OFFICE OF THE COURTS:

For FY26, A cost of \$238,093 per year to pay 50 percent of the superior courts judge salary and 100 percent of the benefits.

Beginning in FY27, ongoing costs of \$247,092 per year to pay 50 percent of the superior courts judge salary and 100 percent of the benefits.

COUNTY:

For FY26, A cost of \$118,233 per year to pay 50 percent of the superior courts judge salary and 100 percent of the benefits. Beginning in FY27, ongoing costs to the county will be \$121,804 to pay 50 percent of the superior court judges salary.
