Part II: Narrative Explanation

II. A - Brief Description Of What The Measure Does That Has Fiscal Impact on the Courts

Section 1 and 2 amends to strike from the definitions under the SRA statute of “Pattern of Criminal Street Gang Activity” subsection x “Any felony conviction by a person 18 years of age or older with a special finding of involving a juvenile in a felony offense under RCW 9.94A.833”.

Section 3 amends the Adjustments to Standard Sentences statute (RCW 9.94a.533) for any person sentenced to multiple firearm or deadly weapons enhancements after the effective date court may order consecutive terms. Also amends subsection 7 to add 2 or more prior offenses or one or more vehicular homicides while under the influence the sentence enhancement must be served in total confinement.
