Part II: Narrative Explanation

II. A - Brief Description Of What The Measure Does That Has Fiscal Impact on the Courts

The substitute bill addresses provisions relating to competency evaluation and restoration services, including appointment and duties of forensic navigators, outpatient competency restoration orders, failure to appear for scheduled admissions, and hearings for involuntary medication determinations, requires the Department of Social and Health Services to establish a growth cap program to manage inpatient competency evaluation and restoration orders, including imposing penalties for counties that exceed a baseline cap of referrals, and establishes necessary elements of behavioral health diversion plans.

This substitute bill retains the same court impacts as the original bill but adds no more.
