II. A - Brief Description Of What The Measure Does That Has Fiscal Impact on the Courts

This bill amends chapter 70.395 RCW concerning minimum requirements for private nongovernmental detention facilities operating under contract with federal state, and local governments regarding detainee care and conditions of confinement and defining actions constituting abuse/neglect; authorizes unannounced inspections by Dept of Health and imposition of administrative penalties; allows appeals of penalties in accord with RCW 43.70.095 (§4(2)(d)); and retains provision authorizing enforcement actions (§2(2)). No significant Court impact notes as existing law already permits penalty appeals and enforcement actions.
