II. A - Brief Description Of What The Measure Does That Has Fiscal Impact on the Courts

The substitute bill removes the requirement to maintain a protection order database, as well as the requirement for courts to send orders to the Administrative Office of the Courts.

TOTAL ESTIMATED COSTS: \$52,200 for FY26

Impacts to AOC:

- New event/docket codes will be required
- Judicial Education

One time cost in FY26 of \$3,500 to update curriculum for judicial education.

System change estimates are 135 hours for preparing requirements, system development and configurations, quality assurance testing, manual updates, and business process documentation.

These are the systems that would be affected:

- Superior Court Management Information System (SCOMIS)
- Data Reporting

The estimate included in the judicial impact note is \$48,700 based on 135 staff hours at an average of approximately \$212 per hour across multiple job classifications needed to complete the interface (Business Analyst, System Integrator, Senior System Integrator, IT Supervisor, and Manager).

Explanation of standard costs by object:

Salary estimates are current biennium actual rates at Step L.

Benefits are the agency average of 30.59% of salaries.

Goods and Services are the agency average of \$3,600 per direct program FTE.

Travel is the agency average of \$2,000 per direct program FTE.

Ongoing Equipment is the agency average of \$1,800 per direct program FTE.

One-time IT Equipment is \$4,800 for the first fiscal year per direct program FTE.

Agency Indirect is calculated at a rate of 25.86% of direct program salaries and benefits.
