II. A - Brief Description Of What The Measure Does That Has Fiscal Impact on the Courts

The second substitute bill adds “environmental justice” as defined in RCW 70A.02.010(8) as required element in environmental impact statements and checklists for State Environmental Policy Act (SEPA) proposals under chapters 43.21C RCW and 197-11 WAC. It also mandates the Department of Ecology to consider said element in evaluating such proposals and include mitigation guidance in implementing rules addressing adverse environmental justice impacts and deems agency duties under chapter 43.21C RCW in additional to those under chapter 70A.02 and includes null and void clause.

The second substitute bill would not make any changes affecting the fiscal impact to the Administrative Office of the Courts or the courts.
