TOTAL ESTIMATED COSTS: For FY26, costs are estimated at \$209,900; for FY27 and ongoing, costs are estimated at \$197,900.

Court Program Analyst (1.0 FTE). Beginning July 1, 2026, and ongoing, AOC would require salary, benefits, and associated standard costs for 1.0 FTE to manage issuance and verification of information for the Hope Card protection order.

Explanation of standard costs by object:

Salary estimates are current biennium actual rates at Step L.

Benefits are the agency average of 30.59% of salaries.

Goods and Services are the agency average of \$3,600 per direct program FTE.

Travel is the agency average of \$2,000 per direct program FTE.
