Part II: Narrative Explanation

II. A - Brief Description Of What The Measure Does That Has Fiscal Impact on the Courts

Section 1 changes the funding responsibilities of public defense services to include both state and local governments. Under the bill, starting in Fiscal Year 2026, the state will be responsible for 50 percent of average public defense costs incurred at the local level. Local governments are required to collect and report data annually regarding the use of public defense services.

Section 2 allows any county with a population density of less than 50 persons per square mile may request that the state Office of Public Defense assume responsibility for providing all or part of the county's public defense services. In these instances, the county opting-in should contribute local funds to the Office of Public Defense in order to cover these expenses.

Section 3 requires an appropriation for the office of public defense.

Section 4 requires the office of public defense to examine caseloads and backlogs and make recommendations to the legislature.

Section 5 requires the administrative office of the courts to collect data detailing the number of cases assigned a public defense and include this information in its annual report.
