The engrossed substitute bill clarifies the documentation an employer must accept as verification of sick leave used for immigration proceedings.

The original bill allowed individuals to use their paid sick leave for judicial or administrative immigration proceedings under certain circumstances. It also required employers and transportation network companies to accept written statements for verification that an individual is using paid sick time for an immigration proceeding.
