# **Part II: Narrative Explanation**

#### II. A - Brief Description Of What The Measure Does That Has Fiscal Impact on the Courts

Section 1(32) defines "safe operational capacity"

Section 2(9) directs DCYF to develop rules related to the safe operational capacity of JR institutions and conditions that must be considered.

Section 2(10) provides options for the Secretary to transfer "sufficient number of people" from JR to community facilities, the department of corrections, or the community to reduce the population.

Sections 3 & 4 incorporate section 2(10) in statue that bars juvenile offenders in community facilities.

Section 5 provides an exception to the requirement that a person convicted as an adult of a felony under the age of 18 is to be initially placed in DCYF. Exception is if the JR facility is at or above 105% of the safe operational capacity.

Section 5(2)(a) states that DCYF cannot transfer person to DOC custody until person is 25 years old unless hearing before review board establishes one of the following: in addition, DCYF establishing that continued placement at JR presents a significant safety risk to other people in the facility. New conditions are added such as: any person who is at least 18 requesting to transfer to DOC; release person to community or a community facility if population of JR facility is 105% of the safe operational capacity.

Section 5(2)(b) states that DCYF should prioritize transfer of oldest who have served longest terms of confinement.

Section 5(5) states that DCYF shall review the placement of persons 21 or older and provide information of voluntary transfer to DOC. DCYF to determine frequency of review.
