II. A - Brief Description Of What The Measure Does That Has Fiscal Impact on the Courts

Section 1 Amends 9.68A.011 (Definitions) for subsection 2 and strikes out "identifiable from the matter itself or from information displayed with or otherwise connected to the matter" and adds "regardless of whether they are identifiable from the matter itself, or information displayed with or connected to the matter."

Section 2 amends RCW 9.68a.040 (Sexual exploitation of a minor—Elements of crime—Penalty) and adds new subsection (1)(d) a person being guilty of sexual exploitation of a minor for knowingly cause a minor to be photographed or part of a live performance which depict the minor engaged in sexual conduct or where the minor is unconscious or unaware of the photograph or recording.

Section 3 amends 9A.04.080 (SOL RCW) and adds dealing in depictions of a minor in sexually explicit conduct first through third degree; possession of depictions of a minor in sexually explicit conduct first and second degree; sending, bringing in state depictions of a minor first and second degree; and viewing depictions of a minor first and second degree not subject to SOL.
