The amendment adds a short title to the provisions pertaining to pregnancy-related accommodations in the workplace, providing that the applicable new chapter may be know and cited as “The Healthy Starts Act”. It also requires a court to grant a request for a delay or excusal from jury service if a person is breastfeeding or expressing breast milk for an infant under 24 months old.
