The amendment revises the process for the meet and confer session between the association and the unit owner, revises the \$80 prevention fee, revises the requirements related to the delinquency for past due assessments and specifies that, if a unit owner was referred to mediation, an association may not commence an action to foreclose a lien on a unit.
