II. A - Brief Description Of What The Measure Does That Has Fiscal Impact on the Courts

The substitute bill permits delinquent assessments to be referred to mediation from judicial or non-judicial foreclosures. It separates the delinquent assessments process from deed of trust foreclosure process and specifies the time window within which delinquent assessments foreclosures may be referred for mediation. It also clarifies the documents to be provided to the mediator and mandates the association to provide its documents first. It removes confidentiality clause and requires all documents to be shared with all parties and mediators and precludes association from filing judicial foreclosure complaint until it receives mediator's certification that mediation completed.

The substitute would not make any changes affecting the fiscal impact to the Administrative Office of the Courts or the courts.
