## Discussion

Requires courts to provide an abstract of driving record to persons violating RCW 46.20.342(1)(c)(iv) (driving while license suspended-3<sup>rd</sup> degree) in a jurisdiction that does not have a relicensing diversion program. There is a fee of up to \$20 paid to the court for providing the abstract. This fee is subject to standard splits for local jurisdiction, State General Fund 40, and Crime Victims Fund.

Counties that operate a relicensing diversion program may charge participants a one-time fee of up to \$100. This fee is not subject to splits.
