RULE OF LAW

Basic HUMAN RIGHTS.

Whether viewed through the lens of:

FEDERAL LAW

STATE LAW

INTERNATIONAL LAW

DIVINE / UNIVERSAL LAW

These principles were the foundation for our country. When the Principles, Laws, Statutes, and Constitution don't line up properly, Chaos ensues. We are there. By default~ the US founding CONSTITUTION prevails.

By plugging in Washington State~ Laws, Codes, Statutes and all added amendments, under corresponding *State* -CONSTITUTIONAL ARTICLES-We find it does NOT line up, is NOT being followed, and has soiled the founding principles of our State Constitution. Giving new meaning to the Good Samaritan theory.

WASHINGTON STATE CONSTITUTION

- SEC 1) POLITICAL POWER is inherent in the people. The governments derive their just powers from the consent of the governed. Established to protect and maintain individual rights.
- SEC 2) CONSTITUTION of the United States is the supreme law of the land.
- SEC 3) PERSONAL RIGHTS, No person shall be deprived of life, liberty, property, without due process.

- SEC 4) RIGHT TO PETITION and to assemble for the common good.
- SEC 5) FREEDOM OF SPEECH, every person may freely speak.
- SEC 6) MODE OF ADMINISTERING AN OATH, will be binding.
- SEC 7) INVASION OF PRIVATE AFFAIRS or HOME PROHIBITED. No person shall be disturbed in his private affairs, or his home invaded, without authority of law.
- SEC 8) ** IRREVOCABLE PRIVILEGE, FRANCHISE, OR IMMUNITY

 ** PROHIBITED** NO law granting irrevocably any privilege or
 immunity shall be passed by the Legislature.
- SEC 9) RIGHTS OF ACCUSED PERSONS, NO person shall be compelled to give evidence against himself.
- SEC 10) ADMINISTRATION OF JUSTICE, in ALL cases shall be administered *openly* and without delay.
- SEC 11) RELIGIOUS FREEDOM~ Absolute freedom of conscience in matters of belief and worship, guaranteed to every individual.
- SEC 12) **SPECIAL PRIVILEGES AND IMMUNITIES PROHIBITED** NO law shall be passed granting to any citizen, class of citizens, or corporations ANY privileges or immunities which are not EQUALLY belonging to all citizens.**
- SEC 13) HABEAS CORPUS shall not be suspended.
- SEC 14) EXCESSIVE BAIL, FINES and PUNISHMENTS.
- SEC 15) CONVICTIONS, EFFECT OF, No conviction shall work corruption of blood, nor forfeiture of estate.
- SEC 21) **TRIAL BY JURY**

- SEC 22) **RIGHT OF THE ACCUSED, to appear and defend in person. To demand the nature and cause of the accusation against him.
- SEC 23) BILL OF ATTAINDER, EX POST FACTO LAW, ETC. NO bill of attainder, export facto law, or law impairing the obligations of contracts shall ever be passed.
- SEC 28) HEREDITARY PRIVILEGES ABOLISHED.
- SEC 29) CONSTITUTION MANDATORY. The provisions of this Constitution are mandatory.
- SEC 30) RIGHTS RESERVED. Certain rights shall not be construed to deny others retained by the people.
- SEC 32) **FUNDAMENTAL PRINCIPLES** A frequent recurrence to fundamental principles is essential to the security of individual right and the perpetuity of free government.
- SEC 35) VICTIMS OF CRIMES RIGHTS. To ensure victims a meaningful role in the Justice system and accord them due dignity and respect. Granted basic and fundamental rights.

US CONSTITUTION:

- AMENDMENT 1) Freedom of religion, speech, the press; rights of assembly. To petition the Government for a redress of grievances.
- AMENDMENT IV) Right to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures.

AMENDMENT V) Rights in criminal cases.

AMENDMENT VI) Right to a fair trial.

AMENDMENT VII) Rights in civil cases.

AMENDMENT VIII) Bail, fines, and punishments.

AMENDMENT IX) Rights retained by the people.

AMENDMENT X) Powers retained by the states and the people.

AMENDMENT XI) Lawsuits against states.

AMENDMENT XIII) Abolition of slavery. Nor involuntary servitude.

AMENDMENT XIV) **CIVIL RIGHTS** DUE PROCESS.

AMENDMENT XIX) Woman's suffrage, the right to vote.

If we plug in our current Washington Laws to the State or Federal Constitution, we find serious discrepancies.

It is best to view Human Rights on it's most simplistic level. For the benefit of all.

While considering factors in the Legality of Disclosure; the Constitutional Requirements, Granting Immunity Status for any Entity, Accountability, Proper Recourse, Stringent Oversight, or equal Justice = equal Disclosure. For all. No exceptions. Justice is in Jeopardy.
