Dear Justice Johnson and Members of the Rules Committee:

On behalf of the District and Municipal Court Judges' Association (DMCJA), I am writing to oppose adoption of the Washington Defender Association-proposed amendments to CrRLJ 3.1.

In our view, it is unnecessary and potentially harmful to change the current rule. The concerns set out in the GR 9 cover sheet for the proposed amendment can all be addressed with a request from defense counsel for an ex parte review. Of greater concern is removing defense counsel's discretion in making the CrRLJ 3.1(f) request. For these reasons, the DMCJA requests that you reject the proposed amendments.
