Re: Legal Voice Comments on Rules of Professional Conduct 4.4 COMMENTARY AMENDMENT

To Whom It May Concern:

Legal Voice supports the commentary amendment to the Rules of Professional Conduct 4.4 and applaud the efforts to protect the rights of immigrants in our state.

Legal Voice, founded in 1978 as the Northwest Women's Law Center, is a nonprofit feminist legal organization that seeks to advance the law for all women, girls, and LGBTQ+ people in the Pacific Northwest. Legal Voice is committed to achieving racial equity and combatting and illuminating the laws, processes and thinking that keep Black, Indigenous, and People of Color outside the "circle of human concern." 1

Amending comment 4 in the Rules of Professional Conduct 4.4 to include prosecutors in the rule's prohibition against reporting people to immigration authorities is appropriate. We strongly believe it is necessary to maintain and promote access to justice for all Washingtonians, regardless of immigration status. Prosecutors are public servants who serve county or city residents regardless of immigration status. When prosecutors are seen as collaborating with immigration authorities, it makes them appear biased against the very people they are bound to serve.

Immigration status or perceived immigration status should not be leveraged against anyone. Thank you for your consideration.
