Rules of Professional Conduct – RPC 4.4 COMMENTARY AMENDMENT

My name is Vanessa Arno Martinez, and, on behalf of the Latina/o Bar Association of Washington, I support the passage of this rule which will protect the rights of immigrants in our state. This matters to us because:

- No one should fear that their immigration status will prevent them from seeking justice, whether as a crime victim or otherwise. All individuals have free and open access to Washington courts, regardless of their immigration status.
- Community trust is a cornerstone of our judicial system. Immigration arrests are causing people to miss court; lawyers should not be facilitating these arrests. Doing so undermines trust in the judicial system.
- Lawyers facilitating courthouse arrests is antithetical to a fair system of justice that must protect all of us. Lawyers must be trusted to keep one's immigration status confidential. Immigration status or perceived immigration status should not be leveraged against anyone.
