Re: Comment in Support of Adopting Proposed JuCR 7.16

Dear Court Rules Committee

On behalf of the Washington State Minority and Justice Commission, we write to express our support for the adoption of Juvenile Court Rule 7.16. Our Juvenile Justice Committee has carefully reviewed the rule and the racially disparate results of bench warrants issued for violations of court orders (VCO) and failures to appear in court. The Committee concluded that JuCR 7.16 will improve the racial equity in the outcomes of the state's juvenile justice system and that it will help keep Black, Native and other youth of color out of detention.

Courts disproportionately issue warrants for these young people. The traumatic effects of an arrest or detention can have a lasting impact on a youth's life, especially for youth who have experienced trauma or come from an economically disadvantaged community. JuCR 7.16 will help reduce the unintended harms of arrest and detention on Black, Native, and other youth of color.²

We recognize that juvenile warrants are sometimes issued to address real concerns regarding threats to a youth's health and safety. Regarding court nonappearance, however, as outlined in the Final Recommendations Report by the Washington State Pretrial Reform Task Force,³ there are less harmful measures courts can use to increase court appearance rates for youth. The same holds true for VCO warrants for violations of probation conditions. It is important and necessary to enlist the intelligence, creativity and wisdom of directly harmed communities as well as the institutional stakeholders in the juvenile justice system. The goals should be to address the underlying reason for the youth's failure to appear or violation of probation, to fashion solutions that will provide long-term positive outcomes for the youth, and to ensure the results are not racially disproportionate – something that arrest and detention cannot accomplish. Because of the harms posed to youth by arrest

and detention and the viable alternatives available, and its likely positive effect on reducing racial disproportionality, JuCR 7.16 should be adopted.

We urge the Rules Committee to recommend adoption of the Rule.
