RE: Support for the MCLE's Board Suggested Amendment to Rule 11 of the Admission and Practice Rules (APR)

Dear Honorable Members of the Washington Supreme Court:

On behalf of the American Immigration Lawyers Association Washington Chapter (AILA-WA) and the Diversity and Inclusion Committee for AILA-WA (AILA-WA D&I Committee), we write in support of the MCLE Board's suggested amendment to Rule 11 of the Admission and Practice Rules (APR).

On September 18, 2020, MCLE Board member Asia Wright presented the suggested amendment to the Board of Governors for review. The suggested amendment would require one ethics credit in the topic of equity, inclusion, and mitigation of bias. The Board of Governors voted 11-2 to support the suggested amendment.

AILA-WA and the D&I AILA-WA Committee are dedicated to helping to educate licensed legal professionals in the topics of diversity, equity, and inclusion. We agree that continuing legal education focusing on these topics is professionally and ethically necessary to develop competence as legal services providers. We recognize that legal professionals have a duty to dismantle existing biases and include previously excluded voices in all aspects of our legal framework.

The AILA-WA D&I Committee has taken steps to address biases, inequalities, and inclusion. In the last several months, we have held three events to encourage awareness,

inclusion, and the eradication of bias.. The members that voluntarily join us express interest, ask questions, and ask for more events to further their increased understanding and corrective actions. We have found a great need and excitement from AILA WA members on these training sessions.

The mandatory nature of this education will promote awareness and change within individuals and the community, education that some might not otherwise seek voluntarily. If this amendment to Rule 11 is confirmed, this will further the opportunities for the legal profession to learn about, and address, systemic inequities that impact our clients, colleagues, and communities - improving the legal system for all.

It is important to note that the American Bar Association has urged all states to adopt its new MCLE model rule that includes MCLE requirements "as a separate credit programs regarding diversity and inclusion in the legal profession of all persons regardless of race, ethnicity, gender, sexual orientation, gender identity, or disabilities, and programs regarding elimination of bias." It is clear that there is a strong need and push for lawyers to learn more about equity, inclusion, and mitigation of bias.

For all of these reasons, AILA-WA and the AILA-WA D&I committee respectfully urge the Court to adopt the suggested amendment to APR 11.
