Regarding the proposed amendment to APR 11 adding 1 hour of required Diversity, Equity, and Inclusion ("DEI") training for Ethics credits requirements, I would oppose this proposed change for the following reasons and believe the Court should reject the proposal.

Justice for all means justice for each and every unique individual, not for one group or another.
