The proposed rule change is one step that must be taken to combat the long history of racial disparity and violence in the United States and the role the legal community has played in upholding white supremacy and systemic injustices.

In addition to adopting APR 11, the Washington legal community must lead uncomfortable and difficult conversations to examine our role in creating and maintaining white supremacy and actively work to dismantle it. APR 11 will help to allow legal professionals to recognize and address our own biases and better represent Washington's diverse community. Building upon this important training, we must also recognize and confront the inequity and injustice that is the legacy of slavery, of Jim Crow, of racial exclusion laws, and of the disproportionate incarceration of BIPOC communities.
