Facts: 98% of pro se Family Law clients in Cowlitz County have no representation assistance. 97% of DV/SV have no representation options in Cowlitz and surrounding counties.

Truth: The same day that the Supreme Court touted awareness of the need for access to justice and BLM, the Supreme Court unanimously, secretly, behind closed doors, decided to "sunset" the LLLT program. Let's call it as it is. The Supreme Court decided to KILL the LLLT career path 275+ students were currently in.

As a Person of Color like several of the Supreme Court Justices, I do not understand this decision. It leans toward sabotaging Access to Justice. Do you know what "sunsetting" alludes to? The LLLTs that are on the collegiate path have jumped through every obstacle and

hurdle thrown at them.
