In addition to probable cause, the court may consider:

(1) Whether an unsuccessful prosecution will subject the State to costs or damage claims under RCW 9A.16.110, self defense or other civil proceedings;

The administration of justice cannot be weighed in monetary cost, the citizen complaint is seldom used, but is in itself one of the checks and balances, to keep our system of government in check. Where government actors chose to act unlawfully and make false statements under oath, to the detriment of the citizen, if it is the prosecutor making the false certification, false statement or perjury, what recourse is left for the citizen.

Even when I have proved that the prosecutor and the Police officer committed perjury under oath, through a public disclosure request from the Washington State Patrol, the response from the bench was Mr. Bolan have a nice day. Fortunately, I had won my case by proving the law that I was charged with violating was unconstitutional, otherwise the lies, false statements made by law enforcement under oath would have been impossible to overcome, it was obvious the officer was lying but how do you prove it. If you have proof there must remain a way to hold them accountable or they will operate with impunity in the future knowing that the citizen has no recourse. Malicious prosecution is a serious problem, perjury on the part of law enforcement and even the prosecutor is a serious problem.

There is no way outside the citizen complaint for these crimes to ever see the light of day, I tried to initiate a citizen complaint in Thurston County but had no idea how to go about it, I filed an affidavit before Judge Sue Dubuisson now retired, she simply refused to hear it. The county was attempting to seize licensed and registered vehicles including my jet skis, claiming abandoned junk vehicles, they were located on private property and are registered to me and were in good condition. The county ordinance cites RCW 7.80 for authority to impose civil infractions i think it was 1000

dollars per day and every day was a new and separate offense. RCW 7.80 decriminalized certain obsolete criminal statutes and any ordinance similar to or the same as these decriminalized statutes were declared to be civil infractions.

examples; killing or maiming an anthwerp carrier pigeon, or removing the band off its foot , failure to return a newspaper or periodical to the library, selling cigarettes below their actual cost, creating video games depicting violence against a police officer, and residential sharps. the ordinances were not the same as any of these things but claimed 7.80 as authority for the fine.

judge Dubuissou, recognized that I had numerous defenses against any civil fine but stated: "just because I chose to store my solid waste on Mr. Kross's property, doesn't mean that I am required to file a complaint against code enforcement."

Licensed vehicles are not junk vehicles or solid waste, the county wanted to steal my property and charge me for it. I never heard from the County on that matter again.

Wrongful acts by government actors, under color of law is a common occurrence and will only increase if the citizen complaint is eliminated.

Any supposed constitutional defect can be remedied by referral to the grand jury for consideration for prosecution, if the judge is limited to determining probable cause. If the prosecution is lying and it can be proven beyond a reasonable doubt this check and balance cannot be eliminated, or the citizen has lost the most important tool to fight against corruption in our government.

I am fighting a case in Aberdeen, after two years I have just blown the case wide open, I built a driveway to my property 24 lots in the city of Aberdeen

### **17.56.060 Surface excavations**

D.Any excavation or landfill shall require a **grading permit pursuant to Chapter 15.08**, with the excavation or landfill of five hundred (500) cubic yards or more requiring an environmental review as provided in Chapter [14.04](#).

Grays Harbor County municipal code

"Surface excavation" means all or any part of the process involved in removing minerals by the removing of overburden and removal of the minerals thereby exposed or the removal of minerals naturally exposed at the earth's surface where such minerals are to be used for commercial, industrial, or construction purposes. The term "surface mining" shall have the same meaning.

**Chapter 64, 1970 1st ex. sess.**

**NEW SECTION. Sec. 4**

For the purpose of this act surface mining shall mean those operations described in this paragraph from which **more than ten thousand tons of minerals** are produced or more than two acres of land is newly disturbed within a period of twelve consecutive calendar months.

**A driveway of less than 100 cubic yards is not surface mining.**

Chapter 15.08 is the uniform building code the 2018 international building code was

adopted by the city council including appendix J entitled; grading. the work i did creating a driveway to my 24 lots was exempt under appendix J any filling or grading in an isolated area that will not adversely affect adjoining properties is exempt from grading permits. Driveways not over 30" above surrounding grade are exempt from building permits under the same code.

The Prosecutor Forest Worgum refuses to drop the charges, and the judge until recently has denied all of my motions and has stated that he is tired of listening to my rhetoric. I cited very clear Supreme court cases showing that the Broadway Addition to South Aberdeen which was platted in 1890 and whose streets were dedicated in 1889, fell under the non-user statute of 1890 and according to the Sanborn fire insurance maps available at the Library of Congress that the city of Aberdeen did not annex that portion of Chehalis county until 1906 so the dedicated streets were vacated in 1895.

The Judge previously denied everything until I submitted the City of Snohomish ordinances on the non-user statute but rather than dismiss the charge of public nuisance he only ordered that the jury had the right to hear the information and denied the prosecutions motion in Limine, denying defense motion for dismissal.

On to trial, the prosecution is malicious. I told code enforcement over two years ago that I would get permits from them when I performed any work required to have permits, and I would contact them when I needed their help. I also told Mr. Bill Sidor not to push me into a corner, that I would come out fighting and he would not like what I found in the law.

Without the citizens complaint, there is no viable means to hold them accountable for malicious prosecution. They know they have no case, but they don't like to lose, and neither do I. RPC 8.4 complaint is all that is left, and disciplinary boards just slap their hands and put them back in the courtroom or back on the Bench, with some continuing education. A grand jury would not be so kind official misconduct and they would loose their bar card. The citizen needs protection against government actors who are abusing their power to the detriment of society. If the Court destroys this last vestige for the redress of grievances it will take an initiative from the people to revive it.

A woman judge in Port Townsend states that in this courtroom there is no presumption of innocence, you are guilty until you prove yourself innocent, a clear violation of due process. I needed my failure to provide proof of insurance dismissed and pay the \$50 dismissal fee, I knew the insurance certificate was in my wallet but didn't find it until after the officer left. If I spoke out against this abuse of power I would not get my ticket dismissed. I watched several defendants wrongfully convicted while waiting for my turn. I paid the \$50.00 and drove the hundred miles back home.

Once a case is over the easy thing to do is to go on with your life, very seldom does anyone try to remedy these problems, I never have, at least successfully even though I knew I must try, the purpose for removing the citizen complaint is to make sure no one ever does. I found the citizen complaint back in the laws of the territory of Washington 1850's, I didn't know anyone knew how to use it, even though I tried. Our Jury system is the fourth branch of the government, jury nullification is a check on the

power to enact and enforce tyrannical laws. Informed citizens is the last line of defense. Jury instructions are an attempt to eradicate that threat to the governments absolute power. The government of the people by the people and for the people, free and autonomous society. Of course this attack on the citizen complaint would come now, close up the avenues of defense from the new world order and their great reset.

Reduce the world population to 500,000,000, uniform system of laws based on Catholic Social doctrine, control reproduction, make room for nature. R. C. Christian Roman Catholic Christian, the Georgia Guidestones.
