Hello Fellow Guardians,

Your input is needed.

The Washington Supreme Court is considering a [proposal](#) to:

- (a) allow more guardians on the CPG Board, and
- (b) limit closed-door Executive Session meetings. See [court order No.25700-A-1379](#).

At the moment, no more than 1/3 of the CPG Board can be guardians, per rule [GR 23](#). Currently only three of the [13 Board members](#) (23%) are Guardians.
