Re: Letter in Support of Proposed Amendments to RPC 1.8(e)

Dear Justice Johnson, Justice Yu, and Rules Committee Members:

The Northwest Justice Project (NJP) writes in strong support of the proposed amendments to RPC 1.8(e), proposed by the WSBA Board of Governors, Committee on Professional Ethics (WSBA). As stated in the GR 9 cover sheet accompanying the proposed amendment, the changes "would permit lawyers to pay court costs and expenses of litigation on behalf of indigent clients, and to provide modest gifts for living expenses to indigent clients in limited circumstances."

NJP is the largest provider of civil legal aid in Washington State, employing over 200 advocates working in 21 offices across the state. Since NJP was formed in 1995, it has closed more than 500,000 cases that have directly benefited over 1,000,000 low-income people in our state. In addition to individual cases, NJP also identifies and addresses prevalent systemic inequities that have benefits for low-income community members across the state.

The proposed amendments expand access to the justice system and will allow NJP to better provide holistic services to our clients. The proposed changes to RPC 1.8(e) largely track the ABA Model RPC, with some modifications, and apply to lawyers representing indigent clients through a nonprofit legal services or public interest organization, and law school clinical or pro bono programs. NJP strongly urges the Washington Supreme Court to adopt the proposed amendments to RPC 1.8(e).
