While we work to connect our clients to social service resources in the community, our clients face particular challenges because many of them are ineligible for some programs that can support basic living expenses due to restrictions based on immigration status. Because of these circumstances, we support the proposed amendment to RPC 1.8 that would clarify that our organization is able to provide modest gifts to help clients with urgent basic needs.

Similarly, we support the proposed amendments to RPC 1.8 because they clarify that we may pay for costs and expenses of litigation on behalf of a client, subject to specific restrictions.

We urge the Supreme Court to adopt the proposed amendments to RPC 1.8.
