The King County Prosecuting Attorney has a policy of punishing defendants when defense counsel submits proposed redactions prior to giving discovery to the client; complaining that it takes time, the PA ceases plea negotiations. Note that one-third of filed felonies are resolved as gross misdemeanors which, according to the policy, would not be available to a defendant who seeks a copy of the discovery.

Defense lawyers are officers of the court. They will follow the rules of redaction. The KCPAO policy assumes that there will be cheating and only a prosecutor can assure that a defense lawyer will not follow the rules.

The local rule should provide that a copy of the redacted discovery be provided to the PAO and filed in the court file.
