Our office has witnessed the positive impact a comprehensive legal team (attorneys, investigators, legal assistants, and social workers) that is well-supported by supervision, administrative, and technical services can have on a person's case. Adopting standards that lower workloads, provide higher compensation, and provide more funding for support staff can only lead to better outcomes for Washington State citizens.

While these changes have costs, the cost of inaction is far greater. The public defense crisis will only worsen, and the expense of addressing it will increase. Now is the time to act and change the course of public defense in our state.
