Re: Proposed Revisions to CrR/CrRLJ 4.1 and CrRLJ 3.2.1

Dear Justice Yu,

The Criminal Rules committees of the Superior Court Judges' Association (SCJA) reviewed the proposed rule revisions of CrR 4.1 CrR/CrRLJ 4.1 and CrRLJ 3.2.1. These rule changes would require in-custody arraignments to be held within three days from the information filing date. The three-day time to arraignment requirement would also apply to defendants subject to conditions of release. The current rules specify that in-custody arraignments must be held within 14 days from filing.

The SCJA is concerned that three calendar days would cause an undue burden for the courts. There are considerations that would make three calendar days impractical, such as holidays and the time it takes to appropriately assign counsel to defendants. Alternatively, the SCJA proposes that in-custody arraignments should be held within five court days from filing. This would significantly reduce the timeline for current in-custody arraignments, while also giving courts enough time to meet their obligations to defendants.
