Due to the upcoming appointment of the incumbent to District Court, the City of Bothell is accepting applications for the position of Municipal Court Judge.

The City of Bothell is seeking a community-minded professional to serve as the Municipal Court Judge. This position is part-time (34 hours a week), appointed by the City Manager and confirmed by the City Council. The City of Bothell Municipal Court processes about 3,000 cases each year.

Qualifications:

A formal education, including a law degree and experience in criminal law; must be a member in good standing of the Washington State Bar. A successful candidate will possess thorough knowledge of current rules of evidence and case law and will have excellent written and oral communication skills. The City of Bothell Municipal Court Judge must have the ability to be completely impartial, to decide cases based on law and facts, and to treat the public fairly. Previous supervisory experience is helpful.

Timeline:

Applications will be accepted only online through August 26, 2019, 5:00 PM. Interviews will be held on September 5, 2019. It is anticipated that the appointment of this position will be confirmed by City Council on September 17, 2019. The appointment term ends on December 31, 2021. Appointments for each term thereafter will follow Bothell Municipal Code.
