## Petition to Withdraw (Rescind) Paternity Acknowledgment / Denial of Paternity

*This form asks the Court to withdraw the Paternity Acknowledgment or Denial of Paternity. It does **not** ask the court to decide who the child's legal parents are. To do that, you must file a Petition to Decide Parentage.*
