I am the guardian/conservator of an individual in another state. That other state has confirmed transfer to Washington State and terminated guardianship/conservatorship. I ask this court to enter a final order accepting transfer of the guardianship/conservatorship to Washington State and enter an order appointing (name) \_\_\_\_\_

as guardian and/or conservator of the individual in Washington.
