RE: Summary of Changes for Domestic Relations Forms (July 2025)

To comply with the legislative mandate in <u>ESHB 1620</u>, the Domestic Relations Pattern Forms Subcommittee created three (3) new forms and undertook significant updates to the Parenting Plan. Several additional forms were updated based on the changes to the Parenting Plan and as required by <u>ESHB 1620</u>. Finally, several forms were updated based on comments.
