The table below outlines changes to the Juvenile forms based on <u>SHB 1391</u>, chapter 13.40 RCW, and comments.

1.	JU 06.0120 Diversion Agreement	Changes: <b>(1)</b> Removed language "By signing this agreement, the offenses listed above will become a part of my juvenile history." <b>(2)</b> In footer, updated publication date.
2.	JU 06.0130 Diversion Agreement – Sexual Exploitation	Changes: (1) Removed language "Signing this agreement enters the above offense onto my juvenile court records as criminal history." (2) In footer, updated publication date.
3.	JU 07.0800 Order on Adjudication and Disposition	Changes: (1) In 4.17, added "offense where a vehicle was used in a manner that endangered persons or property." (2) In 4.18 "Firearm Prohibition," added "; or, (4) the following misdemeanor or gross misdemeanor crime(s) committed on or after July 23, 2023: Domestic Violence (RCW 10.99.020) Stalking; Cyberstalking; Cyber Harassment, excluding when committed solely pursuant to the element set forth in RCW 9A.90.120(1)(a)(i); Harassment; Aiming or Discharging a Firearm (RCW 9.41.230); Unlawful Carrying or Handling of a Firearm 2 (RCW 9.41.270); Animal Cruelty in the Second Degree committed under RCW 16.52.207(1); or, any "prior offense" involving impaired driving as defined in RCW 46.61.5055(14) if committed within seven years of a conviction for any other prior offense for impaired driving under RCW 46.61.5055; or (5) a violation of the provisions of an Order to Surrender and Prohibit Weapons, an Extreme Risk Protection Order, or the provisions of any other Protection Order or No Contact Order restraining the person or excluding the person from a residence, committed on or after, July 23, 2023." (3) In 4.18, updated restoration language to "restored by any superior court in Washington state." (4) In footer, updated publication date.

(2) To Clerks' Action Required in caption, added "2.14." (3) In footer, deleted statute reference to RCW 13.36.237. (4) In footer, updated publication date.
6.	JU 03.0420 Order Continuing Fact Finding Hearing	Changes: (1) In 2.4, added "Clerk's Action.
