#### The Doctors' Trial


The Washington State Law Library is pleased to display material highlighting the work of former Washington Supreme Court Chief Justice Walter B. Beals during the Nuremberg trials following World War II.

In addition to the twenty-four high ranking Nazi officials who were tried by the International Military Tribunal, there were many others who held lesser rank in the Nazi regime who were tried in subsequent proceedings. One of those proceedings was the Medical Case, U.S.A. v. Karl Brandt, et al. (also known as the Doctors' Trial). The Medical Case was prosecuted in 1946-1947 against twenty-three

doctors and administrators accused of organizing and participating in war crimes and crimes against humanity in the form of medical experiments and medical procedures inflicted on prisoners and civilians.

Justice Beals, first appointed to Washington's high bench on April 16, 1928, was nearing the end of an illustrious legal career when, at the age of 70, he received a call from the War Department asking him to serve as a judge on one of the newly formed military tribunals trying Nazi war crimes cases in Nuremberg, Germany. He took a leave of absence from his duties as Washington State Supreme Court Chief Justice in October 1946 and sat as presiding judge over Nuremberg Military Tribunal No. 1, the Medical Case.

After a grueling nine month-long trial, Justice Beals returned to Washington and resumed his duties as Chief Justice. He brought with him one of the few original mimeographed transcripts of the "Judgment of the International Military Tribunal for the Trial of German Major War
