#### Definitions – Juvenile Detention

Juvenile detention in Washington is defined as a facility for juvenile justice-involved youth that:

- provides secure confinement
- is locally operated
- is short term
- can hold youth both pre- and post-adjudication

#### Not included in this definition:

- Admissions to JR facilities (<4% of all incarcerations statewide)</li>
- Admissions to secure or unsecure Crisis Residential Centers

#### We purposefully exclude:

- Holds for out-of-state jurisdictions or Tribes
- Screen and release episodes

Reliable statewide data starting in 2016









# Definitions – Race and Ethnicity

- Imperfect measures
- Little control over data collection
- Court data management system is based on federal reporting standards (OMB, 1997)
- Office of Financial Management (OFM) population data based on US census




### Definitions – Gender

- Court data management system currently limited to binary option:
  - Male (boys)
  - Female (girls)


#### Statewide Juvenile Detention Admissions, 2016-2020




#### Statewide Juvenile Detention Admissions, 2016-2020




## Latinx, Black, and Native American girls are overrepresented in detention admission




#### Youth-level detention rates\* in 2019




## Population vs. Detention Admissions Asian/PI Girls, 2016-2020




## Female Population vs. Female Detention Admissions Native American Girls, 2016-2020




## Female Population vs. Female Detention Admissions Black Girls, 2016-2020




## Female Population vs. Female Detention Admissions Latinx Girls, 2016-2020




## Statewide detention admissions (all genders) steadily declined from 2016 to 2019







In other words, a smaller percentage of detention admissions were accounted for by girls in 2019 than in previous years



## Racial disproportionality for girls *did not* improve with the decrease in admissions from 2016 to 2019






# How has the COVID-19 public health crisis affected juvenile detention admissions?




## Following the "Stay Home – Stay Healthy" order in 2020, statewide admissions (all genders) dropped by about two-thirds




## Statewide admissions remained lower through the end of 2020




#### Detention admissions (all genders) 2016-2020 -




#### Detention admissions 2019-2020




#### Detention admissions of girls 2016-2020





## Summary of findings

- Native American, Black, and Latinx girls are overrepresented in the juvenile detention population statewide
  - Wide variability by county
- > Juvenile detention admission steadily decreased from 2016 to 2019
  - ➤ Higher decrease for girls than boys
  - ➤ No improvement in racial disproportionality for girls (some exacerbation)
- There was a sharp decrease in admissions in 2020 due to COVID-19
  - ➤ Slightly higher decrease for boys than girls
  - Compared to 2019, racial disproportionality stayed consistent or narrowed somewhat (for Black girls)

## Next steps

- ➤ More in-depth look at the COVID-related changes
  - ➤ Quantitative: further examination by populations (including intersectionality), geographic regions, offense types, etc.
  - Qualitative: surveys/interviews with juvenile courts to identify changes in policies and practices
